**INVITATION TO PARTICIPATE IN THE 1<sup>ST</sup> KWAZULU-NATAL PROVINCIAL ANTI-CORRUPTION SUMMIT 13-14 OCTOBER 2008, DURBAN, INKOSI ALBERT LUTHULI INTERNATIONAL CONVENTION CENTRE.**

***THEME: TOWARDS AN INTERGRATED SYSTEM, PROMOTING GOOD GOVERNANCE WITH EMPHASIS ON ANTI-CORRUPTION AND ETHICS***

In November 2004 the National Anti-Corruption Forum (NACF) resolved that all Provinces are required to convene their own respective Anti-Corruption Summits. This was echoed by the Honorable Minister of Public Service and Administration at the Extended National Anti-Corruption on 06 March 2007. The Honorable Premier of KwaZulu-Natal made an announcement to this effect on 11 April 2008, at the Inkosi Luthuli International Convention Centre. He echoed the need to convene the Provincial Summit.

The Provincial Summit aims to bring together decision-makers and all other stakeholders in Anti-Corruption, to address relevant issues that are critical in the fight against corruption. The Provincial Summit will highlight preventative measures and identify challenges for both combating and preventing corruption and promoting professional ethics. The Provincial Summit will also drive the integrated Approach towards a Common Programme of Action.

**SUMMIT OBJECTIVES:**

- Assessing the prevalence and impact of fraud and corruption to service delivery in the Province.
- Exploring effective preventive mechanisms aimed at combating the occurrence of fraud and corruption.
- Strengthening the internal locus of control in the fight against fraud and corruption.
- Examining challenges for both combating and preventing corruption.
- Exploring avenues for promoting professional ethics.
- Uniting sectors in a common programme of action.

Participation at the Summit will be drawn from high level decision-makers in Government Law Enforcement Agencies, State Oversight Bodies, Private Sector, and Civil Society. These will include Ministers, Heads of Departments, Chief Financial Officers, Municipal Managers, Risk

Managers, Special Investigation Managers, Security Managers, Internal Control Managers, and other entities active and involved in Anti-Corruption in the Province of KwaZulu-Natal.
